





- Upgrades to the existing freight rail network between Kwinana and Cockburn.




18 November 2024 Indicative schedule


Westport is moving into its final stage of planning.

Consultancy Contract Awarded for Project Development & Definition (Roe Optional)


Rail projects:

- Cockburn-Kwinana Rail duplication and LXRs

Procurement planning for Rail Project Development & Definition - early 2025

Delivery Contracts:

- Subject to allocation of delivery funding
- Kwinana Freeway / Anketell Road Packages likely first to come to market.



18 November 2024 Marine Procurement

Marine and port infrastructure, KBT, port precinct

- ✓ Late-2024: Geophysical and other site survey underway
- JAN 2025: Geotechnical survey contract award planned
- Q1 2025: Marine and Ports Technical Advisor package released to market
- □ LATE-2025: Integrated Delivery Partner Procurement
- Capital works to follow quickly subject to Government FID – KBT being the priority
- Procurement of operators not imminent (in time for them to design, order and construct topsides and operations)



Engagement of Technical Advisor

Contract summary

- Seeking a collaborative and integrated design partner to deliver a full suite of marine and port related expertise
- Incentivised KRAs (likely to cover key personnel, environmental and sustainability outcomes, time, cost, quality, and training)
- Potentially a staged long-term contract (10 years +) definition support > procurement support > client support in D&C problem solving
- Envisaged one TA, but with options at Westport's election to award full or partial scope of services

Scope of services

- Reviewing Business Case concept designs and assumptions
- Modelling port options and reviewing updated and potentially extended trade and vessel forecasts
- Value engineering; including evaluation of design options and optimisation of port layouts
- Design development to support Project Definition Plan/Project Proposal Report and environmental approval documentation
- Technical support to develop cost estimates
- Providing inputs into RFT documentation for ECI, design and construction or construct only packages
- Operational support including Stevedore terminal design reviews and transition of operations to Kwinana



Non-infrastructure procurement

Other

- ✓ Late 2024: Urban Landscape & Design Framework contract awarded
- □ From 2025: smaller specialised project procurements:
 - System design and performance modelling, specific technology and policy optioning
 - Support for program materials innovation, productivity, materials and logistics supply chains, etc
 - Bespoke commercial support for IDP procurement, stevedore/operator procurement, fees/charges planning
 - Corporate systems updates and review, future PgMO
