# About Westport

Westport is the State Government's long-term program to investigate, plan and build a future container terminal in Kwinana with integrated road and rail transport networks.

We have a once-in-a-century opportunity to design a new port and connecting road and rail networks to benefit the community, industry, and Noongar people.

The Noongar Opportunities Strategy will guide the program in achieving our vision, enabling opportunities to ensure benefits are maximised for Noongar communities with the development of the port and supply chain infrastructure. Learn more about Westport



# Our partnership

This strategy is not Westport's strategy for Noongar people. It is Westport's and the Noongar Advisory Group's shared strategy for how Westport and local Noongar people should develop together.

The Noongar Advisory Group is made up of Traditional Owners, Elders and Leaders of local Noongar people elected by Noongar communities. The Group was formed to ensure Westport was guided appropriately by Noongar people with the authority to provide cultural advice. The Noongar Advisory Group brings together Noongar people from across the Perth Region, including members of Gnarla Karla Booja and Whadjuk Regional Corporations. The Noongar Advisory Group requests that they be acknowledged as 'Noongar people' in this strategy, rather than as Corporations, to recognise their unity in a shared vision for Westport.



- Facilitating partnerships and co-investment on shared actions agreed between Westport and the Whadjuk and Gnaala Karla Booja Noongar Corporations.




## **Noongar Country**

The Westport Program footprint extends into Whadjuk and Gnaala Karla Booja Indigenous Land Use Agreements (ILUAs).

Beyond the physical footprint, the port and network of road and rail will reach across our State and provide a gateway to domestic and international trade.

#### Whadjuk People Native **Title Claim**

Whadjuk is the name of the dialectal group from the greater Perth area. Under the provisions of the Native Title Act 1993 (NTA) the Whadjuk People's native title covers the Perth metropolitan area and surrounds. As a registered claim this gives Whadjuk People, under the NTA, procedural rights to be consulted over activities that occur within their claim.

#### Gnaala Karla Booja Region


The Gnaala Karla Booja region refers to the Noongar language or dialectical groups of the Binjareb/Pinjarup, Wilman and Ganeang. The Westport footprint includes some areas of the Gnaala Karla Booja ILUA region. Due consideration must be given to the range of significant sites that are present to this day.

# Strategy context

#### Part of a bigger picture

Westport is a significant, long-term project, but is just one pathway to deliver outcomes for Noongar peoples. Our strategy and partnerships complement critical existing policy including:

#### Implementation of the Strategy

This Strategy provides the direction for Noongar Opportunities during Westport's delivery of Stage 3 -Business case and planning program. This strategy will be reviewed annually as design evolves.



#### **Action Plan**

Following the release of this Strategy, an Action Plan will be developed. The Action Plan will outline the specific planning activities and approaches that will be implemented to achieve the objectives. We will update the Action Plan annually in Quarter 3 as the planning evolves.

#### Reporting

To build trust and accountability, public reporting of actions and progress will be undertaken on a 6-monthly basis over the planning project.

The Noongar Advisory Group will guide Westport in the implementation and review of this strategy and its Adoption into core business action plan. Advice from this group will be considered The actions and approaches in the action plan will be by the already robust Westport Governance imbedded into the Westport program through: Framework and stakeholder engagement program.

Business case and planning program (2021-24) the project will adopt and deliver the actions.

- Enabling program (2022-24) the management of the enabling fund will consider this strategy in its planning and investments.
- Requirements for Development program (2025 onwards) – the Project Development Plans developed after the Business Case will include specific requirements for the development and procurement of each component of Westport in the next stage.

## **Glossary of terms**

Western term	Aboriginal term	Definition
Noongar	Noongar also spelt Noongah, Nyungar Nyoongar, Nyoongah, Nyungah, Nyugah, and Yunga	The name for the Aboriginal people of the south- west of Western Australia.
Cockburn Sound	Derbarl Nara	The side estuary (Cockburn Sound).
Elders	Birdiya	The custodians of Aboriginal knowledge. Elders are chosen by their own communities. They are highly respected keepers of the knowledge and pass that knowledge on to younger Aboriginal people.
Country	Boodja	The term used by Aboriginal people to refer to the land to which they and their extended family belong. 'Country' for Noongar people is a spiritual and physical connection.
Culture	Kartajin	The customary and traditional ways of living, with a set of common understandings shared by members of a group or community. For Noongar people, this includes attachment to the land and the usage of it as well as language, identity, relationships, and ways of living and working.
Totems	Lore	A totem is a natural object, plant or animal that is inherited by members of a clan or family as their spiritual emblem.
